# 2 Using the Scan Tool

## Tool Description

---

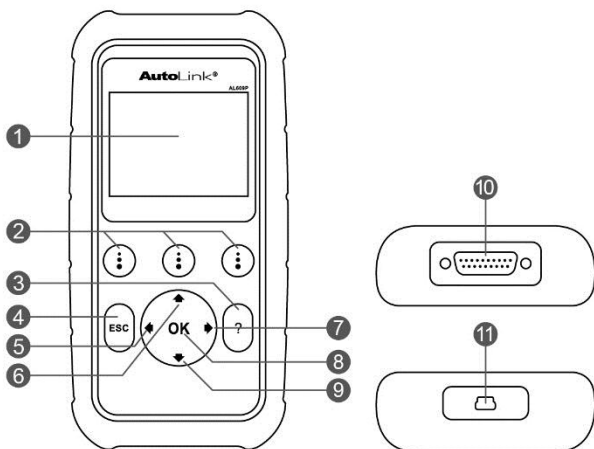


Figure 2-1 Scan Tool View

- 1) **LCD DISPLAY** –displays menus and test results.
- 2) **FUNCTION BUTTONS** – corresponds with “buttons” on screen for executing commands.
- 3) **HELP BUTTON** – provides help information and Code Breaker function.
- 4) **ESC BUTTON** – cancels a selection (or an action) from a menu or returns to the previous screen.
- 5) **LEFT SCROLL BUTTON** – when look up DTC definitions, moves to previous character and views additional information on previous screens if DTC definition covers more than one screen; views previous screen or previous frames of recorded data. It is also used to view previous trouble code when viewing DTCs.
- 6) **UP SCROLL BUTTON** – moves up through menu and submenu items in menu mode. When more than one screen of data is retrieved,

moves up through the current screen to the previous screens for additional data. When looking up DTC, it is used to change value of selected character.

- 7) **▶ RIGHT SCROLL BUTTON** – When look up DTC definitions, moves to next character and view additional information on next screens if DTC definition covers more than one screen; views next screen or next frames of recorded data. It is also used to view next trouble code when viewing DTCs.
- 8) **OK BUTTON** – confirms a selection (or action) from a menu.
- 9) **▼ DOWN SCROLL BUTTON** – moves down through menu and submenu items in menu mode. When more than one screen of data is retrieved, moves down through the current screen to next screens for additional data. When looking up DTC, it is used to change value of selected character.
- 10) **OBD II CONNECTOR** – connects the scan tool to the vehicle's Data Link Connector (DLC).
- 11) **USB CONNECTOR** – connects the scan tool to the PC for printing and upgrading.

## Accessories Included

---

- 1) **OBDII Cable** – provides power to tool and communicates between tool and vehicle.
- 2) **USB Cable** – used to upgrade the scan tool and to print retrieved data.
- 3) **Quick Guide** – instructions on device connection and tool registration and update.

## Keypad

---

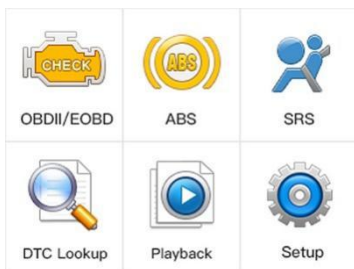
No solvents such as alcohol are allowed to clean the keypad or display. Use a mild nonabrasive detergent and a soft cotton cloth. Do not soak the keypad as it is not waterproof.

## Power

---

The scan tool is powered via the vehicle Data Link Connector (DLC). Follow the steps below to turn on the scan tool:

- 1) Connect the OBD II Cable to the scan tool.
- 2) Find DLC on the vehicle.
  - A plastic DLC cover may be found for some vehicles and you need to remove it before plugging the OBDII cable.
- 3) Plug OBD II cable to the vehicle's DLC.
- 4) The scan tool will power up and the **Main Screen** will appear.

# Vehicle Coverage

---

The AutoLink® AL609P OBDII Scanner is specially designed to work with all OBD II compliant vehicles, including those equipped with next-generation protocol -- Control Area Network (CAN). It is required by EPA that all 1996 and newer vehicles (cars and light trucks) sold in the United States must be OBD II compliant and this includes all Domestic, Asian and European vehicles.

A small number of 1994 and 1995 model year gasoline vehicles are OBD II compliant. To verify if a 1994 or 1995 vehicle is OBD II compliant, check the Vehicle Emissions Control Information (VECI) Label which is located under the hood or by the radiator of most vehicles. If the vehicle is OBD II compliant, the label will designate "OBD II Certified". Additionally, Government regulations mandate that all OBD II compliant vehicles must have a "common" sixteen-pin Data Link Connector (DLC).

For your vehicle to be OBD II compliant it must have a 16-pin DLC (Data Link Connector) under the dash and the Vehicle Emission Control Information Label must state that the vehicle is OBD II compliant.

In addition to OBD II diagnosis, the AL609P scan tool also reads and erases codes for ABS and SRS, dealing with more than 50 US, Asian and European vehicles, including Acura, Audi, Bentley, Benz, BMW, Bugatti, Chrysler, Ford, EU Ford, GM, Honda, Hyundai, Infiniti, Isuzu, Jaguar, Kia, Land Rover, Lexus, Maybach, Mazda, Mini, Mitsubishi, Nissan, Opel, Porsche, Saab, Scion, Seat, Skoda, Smart, Sprinter, Suzuki, Toyota, Vauxhall, Volvo, Volkswagen, Renault, Peugeot, Lancia, Fiat, Dacia, Citroen, Alfa, Abarth.

More vehicle supports will come out with new updates released.

# Product Troubleshooting

---

This part describes problems that you may encounter while using the scan tool.

## Vehicle Linking Error

A communication error occurs if the scan tool fails to communicate with the vehicle's ECU (Engine Control Unit). You need to do the following to check up:

- ✓ Verify that the ignition is ON.
- ✓ Check if the scan tool's OBD II connector is securely connected to the vehicle's DLC.
- ✓ Verify that the vehicle is OBDII compliant.
- ✓ Turn the ignition off and wait for about 10 seconds. Turn the ignition back to on and continue the testing.
- ✓ Verify the control module is not defective.

## Operating Error

If the scan tool freezes, then an exception occurs or the vehicle's ECU (Engine Control Unit) is too slow to respond to requests. You need to do the following to reset the tool:

- ✓ Reset the scan tool.
- ✓ Turn the ignition off and wait for about 10 seconds. Turn the ignition back to on and continue the testing.

## Scan tool doesn't power up

If the scan tool won't power up or operates incorrectly in any other way, you need to do the following to check up:

- ✓ Check if the scan tool's OBD II connector is securely connected to the vehicle's DLC;
- ✓ Check if the DLC pins are bent or broken. Clean the DLC pins if necessary.
- ✓ Check vehicle battery to make sure it is still good with at least 8.0 volts.

---

### NOTE

Avoid electrostatic interference during operation. If a failure occurs due to electrostatic interference, please try to operate again.

---

# 3 OBD II Diagnostics

When more than one vehicle control module is detected by the scan tool, you will be prompted to select the module where the data may be retrieved. The most often to be selected are the Power train Control Module [PCM] and Transmission Control Module [TCM].

**CAUTION:** *Don't connect or disconnect any test equipment with ignition on or engine running.*

- 1) Turn the ignition off.
- 2) Locate the vehicle's 16-pin Data Link Connector (DLC).
- 3) Plug the scan tool cable connector into the vehicle's DLC.
- 4) Turn the ignition on. Engine can be off or running.
- 5) Turn on the scan tool. Use the **UP/DOWN** scroll button to select **OBDII/EOBD** from the **Main Screen**.
- 6) Press the **OK** button to wait for the Menu to appear. With the embedded AutoVIN technology in the tool, a sequence of messages displaying the OBDII protocols will be observed on the display until the test vehicle's protocol is detected. The test vehicle information will display as below once it is done. Press **OK** to continue.

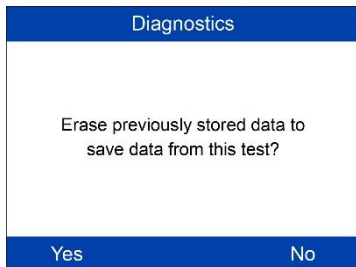
- *If the scan tool fails to communicate with the vehicle's ECU (Engine Control Unit) more than three times, a "LINKING ERROR!" message shows up on the display.*
- ✓ Verify that the ignition is ON;
- ✓ Check if the scan tool's OBD II connector is securely connected to the vehicle's DLC;

- ✓ Verify that the vehicle is OBD II compliant;
  - ✓ Turn the ignition off and wait for about 10 seconds. Turn the ignition back to on and repeat the procedure from step 5.
  - *If the “LINKING ERROR” message does not go away, then there might be problems for the scan tool to communicate with the vehicle. Contact your local distributor or the manufacturer’s customer service department for assistance.*
- 7) View a summary of system status (MIL status, DTC counts, Monitor status) on screen. Wait a few seconds or press any key to continue.

- If more than one module is detected, you will be prompted to select a module before testing.
  - Use the **UP/DOWN** scroll button to select a module and press the **OK** button.
- 8) Then you will be prompted to erase previously stored data.
- *Review previously stored data thoroughly before erasing.*

- *If no data is stored in the scan tool, the above prompt will not show up.*

- 9) If you wish to erase the data, press the **OK** button; if you do not want to erase the data, press **ESC** to exit or use **LEFT/RIGHT** button to select **NO** and press **OK** for **Diagnostic Menu** to come up.

## Read Codes

---

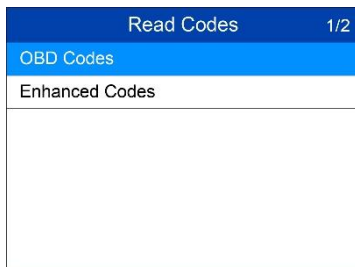
- ◆ *Read Codes can be done with the key on engine off (KOEO) or with the key on engine running (KOER).*
  - ◆ *Stored Codes are also known as “hard codes”, which are fault codes, or trouble codes that have been stored in the vehicle computer memory because the faults have reoccurred for more than a specified amount of key-cycles. These codes will cause the control module to illuminate the malfunction indicator light (MIL) when emission-related fault occurs.*
  - ◆ *Pending Codes are also referred to as “maturing codes” or “continuous monitor codes”. They indicate problems that the control module has detected during the current or last driving cycle but are not considered serious yet. Pending Codes will not turn on the malfunction indicator light (MIL). If the fault does not occur within a certain number of warm-up cycles, the code clears from memory.*
  - ◆ *Permanent Codes are DTCs that are “confirmed” and are retained in the non-volatile memory of the computer until the appropriate monitor for each DTC has determined that the malfunction is no longer present and is not commanding the MIL on. Permanent DTC shall be stored in non-volatile memory and may not be erased by any diagnostic services or by disconnecting power to ECU.*
- 1) Use **UP/DOWN** scroll button to select **Read Codes** from **Diagnostic Menu** and press **OK** button.

- 2) Use the **UP/DOWN** scroll button to select **OBDII Codes** or **Enhanced Codes** from the **Read Codes** menu and press the **OK** button.

- The **OBD Codes** reads pending codes, stored codes, and permanent codes. The **Enhanced Codes** reads DTCs from engine and transmission systems of GM, Chrysler, and Ford vehicles.
- If there is not any Diagnostic Trouble Code, the display indicates **"No (pending) codes are stored in the module!"** Wait a few seconds or press any key to return to previous screen.

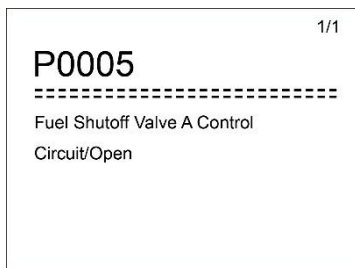
---

**NOTE**

Permanent Codes function is available for merely vehicles supporting the CAN protocols.

---

- 3) View DTCs and their definitions on screen.



**Figure 3-6 Sample DTC Screen**

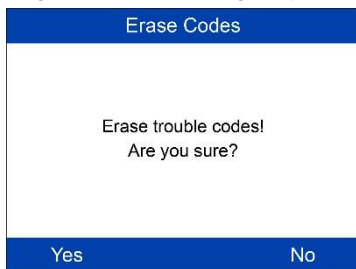
- 4) If more than one DTC is found, use the **LEFT/RIGHT** scroll button to check all the codes.
  - If retrieved DTCs contain any manufacturer specific or enhanced codes, the AutoVIN technology adopted by this tool will automatically display the definition of the code.

## Erase Codes

---

### NOTE

1. Erasing the Diagnostic Trouble Codes may allow the scan tool to delete not only the codes from the vehicle's on-board computer, but also "Freeze Frame" data and manufacturer specific enhanced data. Further, the I/M Readiness Monitor Status for all vehicle monitors is reset to Not Ready or Not Complete status. Do not erase the codes before the system has been checked completely by a technician.
  2. Erasing codes does not mean that trouble codes in ECU have been eliminated completely. As long as there is fault with the vehicle, the trouble codes keeps on presenting.
  3. This function is performed with key on engine off (KOEO). Do not start the engine.
- 
- 1) Use the **UP/DOWN** scroll buttons to select **Erase Codes** from **Diagnostics Menu** and press the **OK** button.
  - 2) A warning message comes up asking for your confirmation.

- If you do not want to proceed with erasing codes, press **ESC** button or use **LEFT/RIGHT** scroll button to select **NO** to exit. A message of "**Command Cancelled!**" shows up. Wait a few seconds or press any key to return to **Diagnostic Menu**.
- 3) Press the **OK** button to confirm.
    - If the codes are cleared successfully, an "**Erase Done!**" confirmation message shows on the display.
    - If the codes are not cleared, then an "**Erase Failure. Turn Key on with Engine off!**" message appears.
  - 4) Press any button to return to **Diagnostic Menu**.

# Live Data

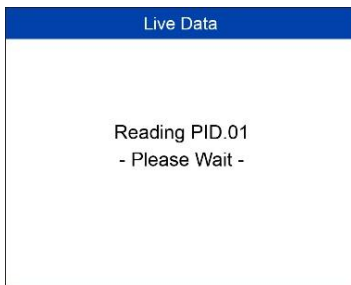
---

In this function, you can not only read the live data but also record data for later review.

## View Data

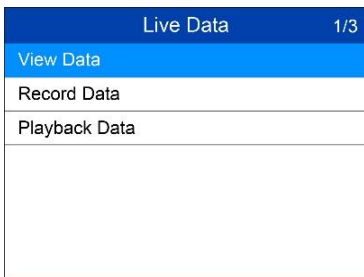
The View Data function allows viewing of live or real time PID data of vehicle's computer module(s).

- 1) To view live data, use the **UP/DOWN** scroll button to select **Live Data** from **Diagnostic Menu** and press the **OK** button.
- 2) Wait a few seconds while the scan tool validates the PID MAP.

- 3) Use the **UP/DOWN** scroll button to select **View Data** from **Live Data** menu and press the **OK** button.

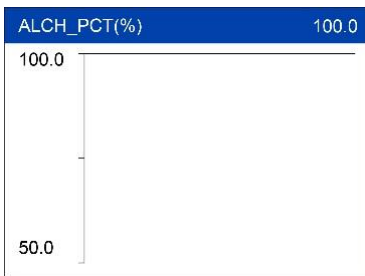
**Figure 3-10 Sample View Data Menu**

- The number “x” to the right of the screen indicates sequence of the highlighted item.
- To view full name of the highlighted PID, press the “?” button.
- If the **G** icon appears when a PID is highlighted, graphic information is available. Press **OK** to view graph.

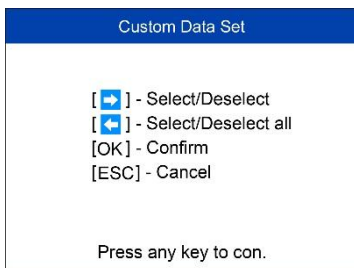


**Figure 3-12 Sample Data Graph Screen**

- 3) Press the ESC button to return to previous menu.

- 1) To view customized PID data, use the **UP/DOWN** scroll button to select **Custom Data Set** from **View Data** menu and press the **OK** button.

- The number “x” to the upper right corner of the screen indicates sequence of highlighted item; and “#x” are the order that the parameters are selected and will be displayed.
  - If you want to deselect all marked items or select all items, press the **LEFT** button. A message comes up to ask for your confirmation.
  - If you decide to deselect these items, press **OK**; if you decide not to, press **ESC** or use the **LEFT/RIGHT** scroll button to select **NO** to continue PID selections.
- 4) Press the **OK** button to view selected PIDs on screen.

- 5) Use the **ESC** button to return to previous menu.

## Record Data

The Record Data function allows recording vehicle modules' Parameter Identification (PID) data to help diagnose intermittent vehicle problems. A recording includes 5 frames of live data before trigger event and several frames after trigger event.

There are two trigger modes used to record data:

- A. **Manual Trigger** – allows user to press the **OK** button to start recording.
- B. **DTC Trigger** – automatically records PID data when a fault that causes a DTC to set is detected by vehicle.

---

### NOTE

DO NOT try to drive and operate the scan tool at the same time! Always have another person operate the scan tool while driving.

---

To record live data, use the **UP/DOWN** scroll button to select **Record Data** from **Live Data** menu and press the **OK** button.

- 1) To record complete set of live data, use the **UP/DOWN** scroll button to select **Complete Data Set** from **Record Data** menu and press the **OK** button.

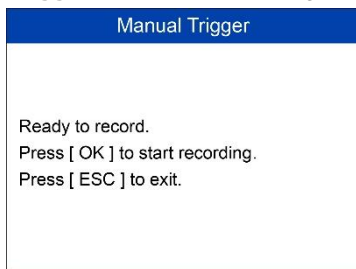

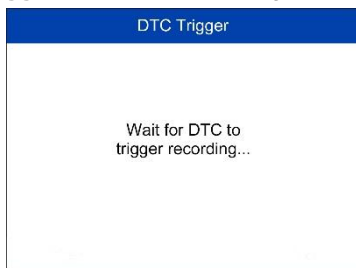

- 5) Use the **UP/DOWN** scroll button to select a memory location and press the **OK** button.
- 6) Observe on-screen instructions to select DTC trigger mode.
- 7) Wait for DTC to trigger recording or press OK to start recording.
- 8) The scan tool keep recording PID data until user presses ESC button, the selected memory location is full, or it completes recording. A message prompting to playback data shows on the screen.
  - If you wish to playback recorded data, press the **OK** button; if you do not wish to playback, press the **ECS** button, or use the **LEFT/RIGHT** button to select **NO** and press the **OK** button to return to **Record Data** menu.

## Playback Data

The Playback Data function allows viewing of previously stored PID data.

- 1) To playback recorded data, use the **UP/DOWN** scroll button to select **Playback Data** from **Live Data** menu and press the **OK** button.

## View Freeze Frame Data

---

**Freeze Frame Data** allows the technician to view the vehicle’s operating parameters at the moment a DTC (Diagnostic Trouble Code) is detected. For example, the parameters may include engine speed (RPM), engine coolant temperature (ECT), or vehicle speed sensor (VSS) etc. This information will aid the technician by allowing the parameters to be duplicated for diagnostic and repair purposes.

- 1) To view freeze frame data, use the **UP/DOWN** scroll button to select **View Freeze Frame** from **Diagnostic Menu** and press the **OK** button.
- 2) Wait a few seconds while the scan tool validates the PID MAP.
- 3) If retrieved information covers more than one screen, use the **DOWN** scroll button, as necessary, until all the data have been shown up.

  - 5) Press **ESC** button to return to previous screen.

## Retrieve I/M Readiness Status

---

I/M Readiness function is used to check the operations of the Emission System on OBD II compliant vehicles. It is an excellent function to use prior to having a vehicle inspected for compliance to a state emissions program.

### NOTE

By clearing trouble codes you also clear the readiness status for the individual emission system readiness tests. In order to reset these monitors, the vehicle must be driven through a complete drive cycle with no trouble codes in memory. Times for reset vary depending on vehicle.

---

Some latest vehicle models may support two types of **I/M Readiness** tests:

- A. **Since DTCs Cleared** – indicates status of the monitors since the DTCs are erased.
- B. **This Drive Cycle** – indicates status of monitors since the beginning of the current drive cycle.

An I/M Readiness Status result of “NO” does not necessarily indicate that the vehicle being tested will fail the state I/M inspection. For some states, one or more such monitors may be allowed to be “Not Ready” to pass the emissions inspection.

There are two ways to retrieve I/M readiness status.

## Retrieve I/M Readiness status in typical way

- 1) Use the **UP/DOWN** scroll button to select **I/M Readiness** from **Diagnostic Menu** and press **OK** button.
- 2) Wait a few seconds while the scan tool validates the PID MAP.
- 3) If the vehicle supports both types of tests, then both types will be shown on the screen for selection.

## O2 Monitor Test

---

OBD II regulations set by SAE require that relevant vehicles monitor and tests on the oxygen (O<sub>2</sub>) sensors to identify problems related to fuel efficiency and vehicle emissions. These tests are not on-demand tests and they are done automatically when engine operating conditions are within

specified limits. These test results are saved in the on-board computer's memory.

The O2 Monitor Test function allows retrieval and viewing of O2 sensor monitor test results for the most recently performed tests from the vehicle's on-board computer.

The O2 Monitor Test function is not supported by vehicles which communicate using a controller area network (CAN). For O2 Monitor Test results of CAN-equipped vehicles, see *On-Board Monitor Test* on page 26.

- 1) Use the **UP/DOWN** scroll button to select **O2 Monitor Test** from **Diagnostic Menu** and press **OK** button.
- 2) Wait a few seconds while the scan tool validates the PID MAP.
- 3) Use the **UP/DOWN** scroll button to select O2 sensor from **O2 Monitor Test** menu and press **OK** button.

## On-Board Monitor Test

---

The On-Board Monitor Test is useful after servicing or after erasing a vehicle's control module memory. The On-Board Monitor Test for non-CAN-equipped vehicles retrieves and displays test results for emission-related power train components and systems that are not continuously monitored. The On-Board Monitor Test for CAN-equipped vehicles retrieves and displays test results for emission-related power train components and systems that are and are not continuously monitored.

The scan tool allows access to the results of on-board diagnostic monitoring tests for specific components/systems. The vehicle manufacturer is responsible for assigning "Manufacturer Defined Test IDs" and Component IDs for tests of different systems and components. The advanced feature of this scan tool enables you to read the definition of an On-Board Diagnostic Monitor ID.

---

### **NOTE**

The scan tool will display a Test definition only if this test definition is present in the vehicle's computer memory. If no such definition is present, the scan tool will just display the Test IDs.

---

In this test, there are typically a minimum value, a maximum value, and a current value for each monitor. By comparing the current value with the minimum and maximum value, the scan tool will determine if it is OK.

- 1) Use the **UP/DOWN** scroll button to select **On-Board Mon. Test** from **Diagnostic Menu** and press the **OK** button.
- 2) Wait a few seconds while the scan tool validates the PID MAP.
- 3) The scan tool will prompt you to select the vehicle make.
- 4) After you select the vehicle manufacturer, the scan tool shows the On-Board Monitors test results for specific monitored systems.

---

The Component Test function allows initiating a leak test for the vehicle's EVAP system. The scan tool itself does not perform the leak test, but commands the vehicle's on-board computer to start the test. Different vehicle manufacturers might have different criteria and methods for stopping the test once it has been started. Before starting the Component Test, refer to the vehicle service manual for instructions to stop the test.

- 1) Use the **UP/DOWN** scroll button to select **Component Test** from **Diagnostic Menu** and press the **OK** button.
- 2) Wait for the scan tool to display the **Component Test** menu.

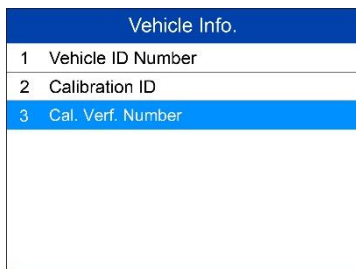

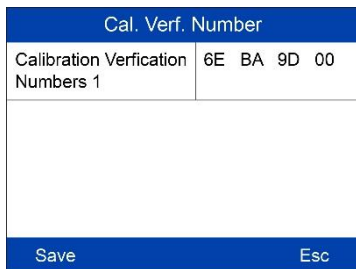
**Figure 3-39 Sample Vehicle Info. Screen 1**

# 4 ABS

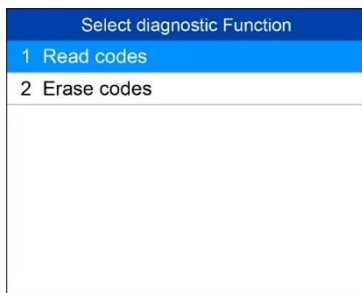
An anti-lock braking system (ABS) is an automobile safety system that allows the wheels on a motor vehicle to maintain tractive contact with the road surface according to driver inputs while braking, preventing the wheels from locking up (ceasing rotation) and avoiding uncontrolled skidding. It is an automated system that uses the principles of threshold braking and cadence braking which were practiced by skillful drivers with previous generation braking systems. It does this at a much faster rate and with better control than many drivers could manage.

An ABS warning lamp that is on usually means trouble and you need to pull the code to figure out what is wrong. The AL609P provides convenient service to read and erase codes for the ABS.

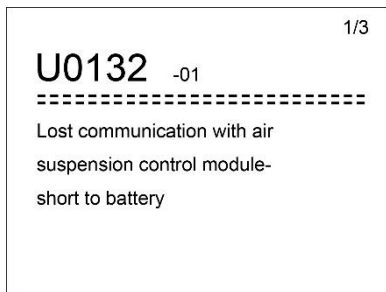
## Read Codes

---

1. From **Main Screen** (*Figure 2-2*), use the **UP/DOWN** scroll button and **LEFT/RIGHT** scroll button to select **ABS** and press the **OK** button.

**Figure 4-1 Sample Diagnostic Function Screen**



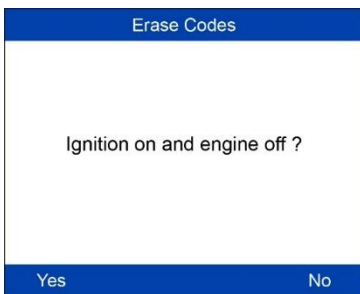
**Figure 4-2 Sample Trouble Codes Screen**

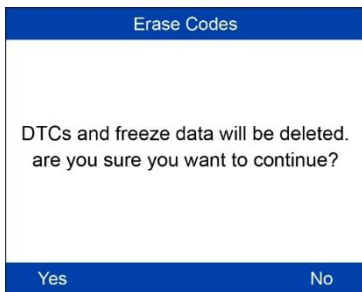

# 5 SRS

The purpose of the SRS light on your instrument panel is to alert you of a potential problem with your supplemental restraint system.

Use the AL609P to have the system checked if:

- The light does not come on when you turn the ignition ON.
- The light stays on after the engine starts.
- The light comes on or flashes while you are driving.

## Read Codes

---

1. From **Main Screen** (*Figure 2-2*), use the **UP/DOWN** scroll button and **LEFT/RIGHT** scroll button to select **SRS** and press the **OK** button.
2. Select **Read codes** from the diagnostic function list (*Figure 4-1*).
3. All the DTCs of the ABS control module are displayed. The data will be automatically saved for later review.

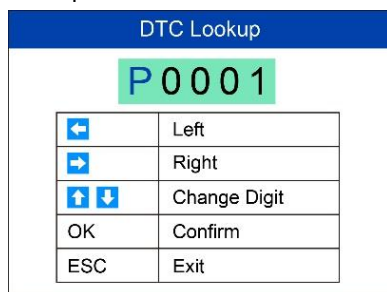

The DTC Lookup function allows user to search definitions of DTC stored in built-in DTC library.

- 1) From **Main Screen** (Figure 2-2), use the **UP/DOWN** scroll button and **LEFT/RIGHT** scroll button to select **DTC Lookup** and press the **OK** button.
- 2) From **DTC Lookup** screen, use the **LEFT/RIGHT** button to move to the desired character, use the **UP/DOWN** button to change selected digit/character and press the **OK** button to confirm.

- 3) View the DTC definition on screen. When DTC definition covers more than one screen, use the **LEFT/RIGHT** button or **UP/DOWN** button to view additional information on previous/next screens.
  - If retrieved DTCs contain any manufacturer specific codes, the AutoVIN function embedded in this tool will automatically display the definition of the code.
  - If definition could not be found, the scan tool displays "**Please refer to vehicle service manual!**"
  - For code breaker information, you need to press the "?" **Help** button.

In the **Code Breaker** screen, there are three options to assist user to understand DTC more: **System Description** and **Quick Check** to read detailed description of DTCs, **General Notes** to view helpful repair information of DTCs.

- 4) To view previous or next DTC in the built-in DTC library, use the **LEFT/RIGHT** button.
- 5) To enter another DTC, press the **ESC** button to return to previous screen.
- 6) To exit to **Main Screen**, press the **ESC** button.

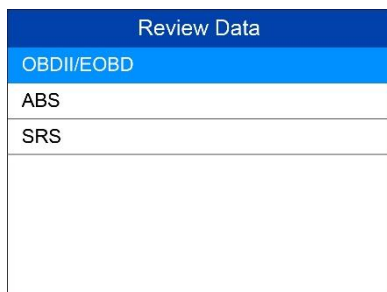
# 7 Playback Data

The Playback function allows viewing and printing of data from last test recorded by the scan tool.

- 3) Use the **UP/DOWN** scroll button to select the desired DTC entries from **OBD II/EOBD** or **ABS** or **SRS** menu, and press the **OK** button to view details of the trouble codes saved during the vehicle examine.

## Delete Data

---

By selecting **Delete** on the review screen (*Figure 7-1*), you are allowed to erase the selected data on the scan tool. Review the recordings thoroughly before erasing. You could also erase all recordings by select **Delete All**.

### NOTE

Don't use **Delete All** unless you are definitely sure what you are going to proceed.

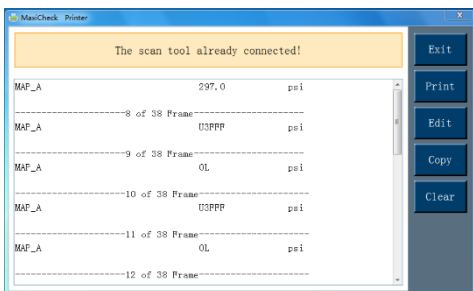
## Print Data

---

By selecting **Print** option on the trouble codes screen, you are allowed to send the recorded files to your computer and then to the printer.

The Print Data function allows printing out DTC data recorded by the scan tool by connecting the scan tool to a PC or laptop with the USB cable supplied.

- 1) Download the **Maxi PC Suite** from [www.autel.com](http://www.autel.com) and install.
- 2) Connect the scanner to computer with the USB cable supplied.
- 3) Run **Autel Printer** software on computer.
- 4) Select **Playback** function in Main Screen of the scan tool. In **Scan/OBDII** screen, use the **UP/DOWN** scroll button to select the data you want to print. Wait for the reviewing window to display, and then select **Print** function. The selected file will be uploaded to your computer. For more detailed instructions, please refer to **4. Playback Data**.
- 5) The **Printer** will show as below.

- 6) The selected data will display on the textbox of **Printer**. By selecting the function keys on the right, you could execute the following operations:
  - Print – Print all data in the textbox to a printer connected to your computer.
  - Edit – Once clicked, the software will automatically open a NOTEPAD window with all recorded data displayed.
  - Copy – Copy all data in the textbox to the clipboard.
  - Clear – Delete all data in the textbox.
  - Exit – Quit the operation.
- 7) You are also allowed to edit, copy, and delete the data in the **Printer** window.



---

 **NOTE**

The scan tool can only print text data even though the data is saved in graphic mode.

The print function is not available on Mac for the present.

---

# 8 System Setup

The System Setup functions allow you to adjust default settings and view information about the scan tool.

- 1) **Language:** Selects the desired language.
- 2) **Unit of Measure:** Sets the unit of measure to English or Metric.
- 3) **Key Beep Set:** Turns on/off beep.
- 4) **About:** Provides information of the scan tool.
- 5) **Tool Self-test:** Checks if the LCD display and keyboard are working normally.
- 6) **Update Mode:** Accesses the Update Mode.
- 7) **Vehicle Info Show Set:** Turns on/off the Vehicle Info display.

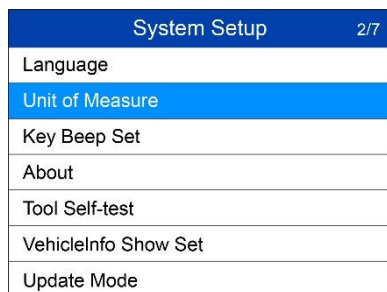

- 2) Use the **UP/DOWN** scroll button to select the desired language and press the **OK** button to save your selection and return to previous screen.

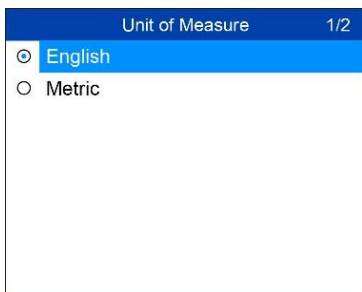


**Figure 8-2 Sample Language Screen**

---

  - 2) From **Key Beep Set** menu, use the **UP/DOWN** scroll button to select **Beep ON** or **Beep OFF** to turn on/off the beep.

## Tool Self-test

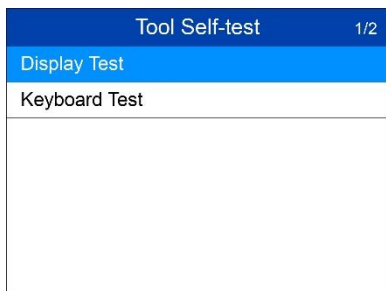
---

The Tool Self-test function checks if the display and keyboard are working properly.

### Display test

The **Display Test** function checks if the LCD display is working normally.

- 1) From **System Setup** screen, use the **UP/DOWN** scroll button to select **Tool Self-test**, and press the **OK** button.
- 2) Select **Display Test** from **Tool Self-test** menu and press the **OK** button to start test.

- 3) Look for missing spots in the red, green, blue, black and white LCD display.
- 4) When completed, press the **ESC** button to exit.

## Keyboard Test

The **Keyboard Test** function verifies if the keys are functioning properly.

- 1) Use the **UP/DOWN** scroll button to select **Keyboard Test** from the **Tool Self-test** menu (Figure 8-6), and then press the **OK** button.
- 2) Press any key to start test. When you press a key, the key name should be observed on the display. If the key name does not show up, then the key is not functioning properly.

## Update Mode

---

This function allows you to update the scan tool software through a Mac or a Windows-based computer.

A USB cable

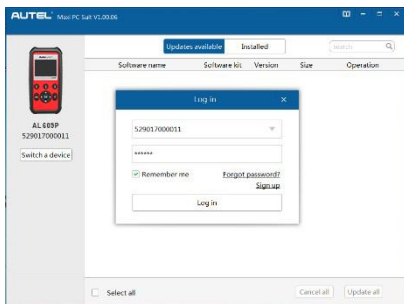
## Update Procedure

Connect the device with a Mac or a Windows-based computer using the included USB cable.

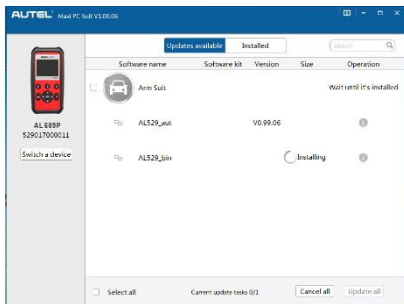
Follow the update procedure to finish updating. The Windows version is taken as an example here.

3. Connect the scan tool to your computer through the USB cable provided.

### Single Update

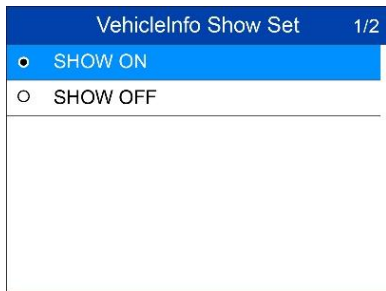
1. Find out the desired updating item and click the **Update** button in the same line.
